REGULAR BOARD MEETING

The Town of East Fishkill's Town Board Meeting on September 28, 2023, was called to order at 6:00 p.m. by Supervisor D'Alessandro with the Pledge of Allegiance to the Flag, led by Boy Scout Troop 3086.

Supervisor's Presentations

Supervisor D'Alessandro stated he had a presentation for a fire district member James Forde, for over 50 years of service to the East Fishkill Fire District and the Town of East Fishkill. He presented Mr. Forde with a proclamation. Mr. Forde stated he hopes to continue to serve as long as he can.

There was a proclamation for Troop #3086. They were awarded the American Legion New York Boy Scout Troop of the year and Supervisor D'Alessandro and a Commander from the Manny Bacon American Legion post presented it to those members present. Supervisor D'Alessandro thanked them for all their service. The Commander presented a plaque to them from New York State. A boy scout representative thanked the American Legion for being their charter organization and thanked East Fishkill for the award.

Supervisor's Announcements

Supervisor D'Alessandro stated it was a very special night when they can honor the Fire District and the Boy Scouts at the same time.

Supervisor D'Alessandro welcomed Assemblyman Beephan to the meeting. The month started with the Dutchess County Supervisor and Mayor Association meeting. They were at the BOCES center in Hyde Park and were given a summary on their purpose and services.

He attended the Dutchess County Transportation Safety Council meeting. It was at the FDR Library in Hyde Park and it was the voting meeting. This group funds many projects throughout the county. He also met with them at the Beacon Town Hall for the Beacon/Hopewell Rail Trail Study. They will be doing a feasibility study for this. It will be a very in-depth study. It is very beneficial having these rail trails converge in Hopewell Junction.

The Dutchess County Economic Development Advisory Council met. They make recommendations to the County Executive's office for projects and policies. It is made up of different business and industry leaders. There is an inventory shortage in the whole area for apartments and single-family homes.

Congressman Lawlor usually has a bimonthly meeting with town supervisors of the three towns he represents. There was also a town hall style meeting at John Jay High School.

Community Day has been postponed due to the rainy weekend. It has been rescheduled for Sunday, October 8. There is a lot of work that goes into this each year.

Supervisor D'Alessandro has been working with the East Fishkill Grants Director and they are preparing for multiple grant applications. One will be the Downtown Revitalization Grant which is a \$10 million grant given out one time per year per region. There is also the Dutchess County Community Development Block Grant application which they are also working on. It will be written for water bottle filling stations at the Depot location. This would be the only water fill station from the beginning of the trail to Westchester County. They are also preparing a grant for the Fast New York Grant Application for the Route 52 Water Improvement area. They are also applying for federal funding through Senator Schumer's office for this project. He thanked everyone who is working on these projects. Grants are a lot of work.

Dutchess County has been nationally recognized for their use of technology to prove how government connects with the residents. The Dutchess County Office for Central Information Services has received a 2023 Government Experience Award. They rank fifth place nationwide. The Commissioner of the committee is from East Fishkill and Supervisor D'Alessandro congratulated Dr. Glenn Marchi on this award.

It is budget season for all New York State municipalities. He has been working with the Comptroller for the past three weeks on this and the tentative budget will be presented tonight to the Town Board. They will have a budget workshop meeting in October and the Public Hearing will be at the October voting meeting. He thanked the Comptroller for all of his hard work on this. East Fishkill never breaks the tax cap and he does not believe they ever will. The Town Board is very diligent in how tax money is spent. He thanked the Board as well.

Yesterday Board Member Flores and Supervisor D'Alessandro attended a meeting at George Fisher Middle School in the Carmel Central School District. They are looking to hire a new school superintendent. This meeting was to get multiple opinions on what was wanted in a school superintendent. Supervisor D'Alessandro's response to them was good communication.

Supervisor D'Alessandro stated they were going to change the order of the Public Hearings for the night so the first one would be for the tax exemption.

Public Hearings:

1. Open Adjourned Public Hearing to Consider Regulating Airbnb Uses with the Town(Short Term Rentals)

Motion to open the Public Hearing to consider regulating Airbnb uses within the Town (short term rentals): Board Member Franco. Seconded: Board Member Flores. All voted in favor. Motion carried.

Attorney Wood stated last month they went through the local law but they could not finalize it as they were still waiting for comments from Dutchess County Department of Planning. We have since received those and they are very supportive. This is the first step in East Fishkill to regulate when a person chooses to utilize their real property for short term rentals. This will give us a handle on where those properties are. They will have to be inspected and comply with all the health department regulations. There will be an occupancy limit with respect to no more than two people per bedroom. It requires them to have a responsible party available so if there is an incident the police or a representative of the town will be able to reach somebody who has to respond to the property within 60 minutes. It also requires that any garbage or refuse that is created be placed out the night before for collection. There have been some situations in the town where it has been there for a week at a time. It mimics that no property that has a shared driveway can be utilized for this purpose. The intent for shared driveways is to allow access by the residents who share that area. There is a fee and a registration requirement. It will start to give the Town a better handle on what is occurring. Towns all across the state have been struggling with this and there are variations of how towns are choosing to regulate it. This is our attempt to begin to regulate it and get a handle on the numbers that we have. We only know of situations where there had been a complaint or issue. There are only a few of them but they appear to be very stressful to the residents surrounding those properties. If it is adopted this evening it will go into effect within the next 15 days. Then the Building Department can commence enforcement.

Supervisor D'Alessandro stated there were many comments received last month. Supervisor D'Alessandro asked if anyone in the audience wish to speak for or against this proposed law.

Resident #1 said that last month they mentioned there was a certain amount of land required for this use. She asked if that was still a requirement and Attorney Wood said yes. Resident #1 one asked what the requirement was in the Hillside Lake area. Attorney Wood stated they are allowed in all residential areas except

the R 1/2 acre, R 1/3 acre, and R1/4 acre. So basically you need an acre or more.

Supervisor D'Alessandro asked if there were any Town Board members with any questions or comments.

Board Member Marinaro asked if there was one law that would cover all the areas in New York State. Attorney Wood stated at the current time it is up to the individual municipalities.

a. Close Public Hearing

REASONS SUPPORTING THIS DETERMINATION:

The proposed action would result in the adoption of a local law for short term rentals. The law includes provisions allowing short term rentals provided certain provisions are met to ensure that the general welfare of the community is protected. In addition, the law sets application and enforcement fees for short term rentals. The proposed local law is expected to support the regulation of short term rentals in the Town of East Fishkill and protect public health and safety. Therefore, the proposed action would not be expected to result in any significant adverse impacts for the following reasons:

1. It will not generate a significant amount of additional vehicles, noise or emission levels.

2. It will not affect rare or endangered species of animal or plant, or habitat of such species.
3. It will not result in any impacts to historic or archeological resources.
4. It will not result in any impacts related to hazardous materials.
5. It will not result in a significant effect on air, water quality or ambient noise levels for adjoining areas.

Local Law No. 4 of 2023
(A LOCAL LAW TO IMPLEMENT SHORT-TERM RENTAL REGULATIONS WITHIN THE TOWN OF EAST FISHKILL)

Section 1. Legislative Intent

Like all communities, the Town of East Fishkill has noticed an increase in short-term rentals being advertised on websites such as Airbnb and VRBO. While the Supervisor and Town Board can understand the draw of short-term rentals in East Fishkill for both

vacationers and owners of rental properties, it is imperative that safeguards are put in place to ensure that the general welfare of the community is protected.

Section 2. Regulation of Short-Term Rental Properties

The following provisions shall be added to the Town Code related to short-term rentals:

1. **Applicability:** these restrictions shall apply to all rentals of dwelling units for a term of thirty (30) days or less. These rental units shall be referred to as “Short-Term Rental Properties”.
2. **Restrictions:** The following restrictions shall apply to all Short-Term Rental Properties:
 - a. The owner of a Short-Term Rental Property shall register the property with the Building Department. The information provided shall include the name, address, and contact information for the owner as well as the name, address, and contact information for the local agent, if different from the owner. As part of the registration process, each applicant shall submit proof of compliance with State Building and Fire Codes from an inspector and shall complete an annual fire inspection.
 - b. Short-Term Rental Properties shall not be located in anything other than a single-occupancy building
 - c. Short-Term Rental Properties are allowed in all residential districts except in the R-1/2, the R-1/3, and the R-1/4 Zoning Districts. They shall also be prohibited on properties with non-conforming lots.
 - d. All Short-Term Rental Properties must provide proof to the Building Department that the sanitary sewer or septic system has the capacity for the number of bedrooms in the structure
 - e. Short-Term Rental Properties are prohibited from sharing a driveway with another property
 - f. Garbage and other refuse can only be left out for collection the night before pickup, and all refuse containers shall be removed from the curb once emptied
 - g. Short-Term Rentals may not advertise for occupancy greater than two (2) people per bedroom
 - h. The owner of the property or the owner’s agent must respond and be present at the property upon sixty (60) minutes notice when the property is rented
3. **Fees:** All properties used as a Short-Term Rental shall pay a yearly fee of \$500
4. **Penalties:** Any person or other legal entity found to be in violation of the Short-Term Rental Restrictions shall be fined \$350 for the first offense, \$700 for the second offense, and \$1,000 for all subsequent offenses. Upon the third offense, the Town of East Fishkill may revoke the permit for the owner to operate a Short-Term Rental Property.

Section 3. Severability

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 4. Effective date

This local law shall take effect immediately upon filing with the Secretary of State.

Supervisor D'Alessandro asked if there was anyone who wanted to speak about any general town issues or had any comments on the CDBG Grant Application to be included in the application.

Resident #2 thanked the Highway Superintendent for speaking with him before the meeting regarding his plans for Hillside Lake and for taking time to drive around with Mr. Grasso. He thanked the Town for their work on the actual lake. There have been no lily pads showing up. He asked if that work was completed. Supervisor D'Alessandro stated the lily pads are because there is a treatment done to the lake and they will continue to do that. They are in the midst of a review for the dam as it is old and needs repairs. They are also looking into a new culvert. They did get a grant for part of that but they are looking into funding. Resident #2 also spoke about the line of sight on various roads in that area and at Van Wyck drop off. Highway Superintendent Williams stated he would reach out to try to get some trees cut back. Board Member Marinaro stated the County does have information on the last five years of accidents in those areas. They also did review the school drop off. Supervisor D'Alessandro stated DOT controls that traffic light. Board Member Marinaro stated they may have to go back to school again.

Robert Grasso spoke about the three stop signs at Hillside Lake. Highway Superintendent Williams did acknowledge that there are some people who do not stop at those signs. Supervisor D'Alessandro suggested Mr. Grasso get a petition from the residents for the Town to consider installation of a speedbump.

Resident #3 spoke about road conditions in Hillside Lake. Superintendent Williams will look into it. He will be meeting with some of the residents next week.

WHEREAS, the Town of East Fishkill does have affordable for-sale units and may from time to time have additional units; and

WHEREAS, the “Affordable Units” have been developed in compliance with Article XXIII, Section 194-164 of the Town’s Zoning Code; and

WHEREAS, it is the desire of the Town Board to have the “Affordable Units” be administered and monitored in compliance with the Moderately Priced Housing Program; and

WHEREAS, The ROUTE 52 COMMERCIAL WATER IMPROVEMENT AREA is seeking funding support that requires Engineering Plans and Reports for the improvement of a water system; and

WHEREAS, the Improvements will include watermain extensions, booster pumps, water storage tank, and water treatment; and

WHEREAS, the Town previously sought and has been awarded funding for the interconnection of several water districts, the replacement of a portion of watermains at Hopewell West WD, as well as the razing of several non-functional water plants; and

WHEREAS, the Town prepared plans and specifications for the demolition and material disposal at Revere Park water treatment plant, Hopewell West water treatment plant, Brettview water treatment plant, and minor material disposal at Fishkill Plains water treatment plant, known as Phase 3A; and

WHEREAS, the New York State Department of Health and Dutchess County Department of Health have reviewed and approved the plans and specifications describing the proposed construction work on August 21, 2023; and

WHEREAS, the Town publicly advertised the bid package on BIDNET and Southern Dutchess news starting on August 23, 2023 and performed a public site walk on September 12, 2023, followed by receiving bids on September 18th, 2023; and

WHEREAS, the Town received one bid response and has determined that SUNCO, INC is the lowest cost, qualified, responsive bidder that agrees to comply with New York State Environmental Facilities Corporation requirements include M/WBE goals, use of American Steel, etc.; and

NOW THEREFORE, IT IS RESOLVED, that the Town Board hereby declares and Authorizes Nicholas D'Alessandro, Town Supervisor, be provided the authority to authorize a contract with SUNCO, INC. for services described in Contract WS2023.01 Hopewell West, Revere, Brettview Water Districts Buildings Razing in an amount not to exceed \$163,450.00.

Motion to authorize bid award for Contract WS2023.001 Buildings Razing: Board Member Franco. Seconded: Board Member Flores. All voted in favor. Motion carried.

7. Appoint Seasonal Employee Tax Receiver's Office

Members of the Sons of Italy were present and thanked the Board for their time. A representative stated for close to 40 years they have been hosting the Memorial Day event at the Town Recreation. The profits made at this event go back into the community. This year their scholarship donations will be doubled. They made a donation to the Town of \$2,000.00, which they presented to the Comptroller. They also made a presentation of a check to the East Fishkill Rescue Squad for \$1,500.00 for equipment. Supervisor D'Alessandro thanked them for their generosity.

Comments from Town Board Members:

Highway Superintendent Williams stated it has been a wet and busy month. They have completed the collaboration paving project with the Town of Kent on Long Hill Road. They do have some shoulder work left. He thanked the Town of Kent Highway Department for their participation. As of now they are scheduled to pave Probst Terrace, Patricia and Jess Court, Verplanck and Potter all next month, weather permitting. They have also been doing a lot of pipework on Potter Place and Verplanck, Jess Court and Patricia. They have also done pipe work on Memory Lane and Townsend road. They have installed curbing on Ridge Road, Oakridge Drive, Martin Road, some in Brettview, Elton's Way, Cross Road, Townsend Road, and Mountain Pass. They have also been doing some basic layouts. The roadside mower has been very busy. They are doing tree work on Creamery Road, Butternut Lane, Probst Terrace, Long Hill Road, Old 52 and Leetown Road. They have done grade all work on the mountain roads. They have had a subcontractor out doing seam sealing on roads that have been paved within the last 7 years. Hopefully next month will be drier and they will be able to get the paving done. He thanked the Board for their new equipment. He stated Councilman Arco has been a tremendous voice for the Highway Department.

Town Clerk Cassidy stated Community Day is October 8. Bring a jacket it will be chilly and plan to stay all day. It is the first time ever it has had to be postponed. Supervisor D'Alessandro stated that when the Town Clerk was a Councilman he and Councilwoman Walker started Community Day.

Board Member Arco thanked the Board for their assistance with the Highway Department and their vehicle purchases. The shop and field crews have been working very hard preparing for winter. This past week he attended a local highway event in Poughkeepsie which included East Fishkill and multiple adjacent towns. The vacuum truck should be here within the next few weeks. He did an audit on one of the newly purchased vehicles to make sure it is being maintained and kept neat and everything has been more than satisfactory. In regard to the Fire District there was a coordinated walk-through at the iPark section of the complex. That is approximately 2,000,000 sq. ft. It will take a while to gain site and systems knowledge. One of the stations has been involved in a drill there this past month. This is crucial for them to be able to respond appropriately. They are also trying to perform other standalone walk-throughs of independent tenants as well. He thanked everyone for their help in this process. ON Semi was beyond cooperative with their tour and explanations. There was also a walk-through at the new Amazon facility. Walk-throughs will also be scheduled regularly with the Amazon Loss Prevention and Safety Department. There was a meeting set up next week with the Fire Commissioners and a few County legislators to discuss issues with EMS and he will follow up with the Board after that.

Board Member Marinaro stated the Police Department has been very active and busy. He reviewed several incidents including some at John Jay. There were rumors circulating about firearms involved in an issue and that is not the case. There were a few fight incidents, and the Police Department is investigating and

dealing with it. There are issues in the Town with aggressive driving. There will be special patrols dedicated to addressing this issue. The Mental Health of America partnership is going as planned and the specialist is currently training and doing ride alongs with the officers. The PBA will be contributing an obstacle course, dunk tank, and K9 demo to the October 8 Community Day events. Board Member Marinaro has been meeting regularly with the Interim Police Chief Cuccia and Lieutenant Stanis. They review situations within the community and how they are handled. They will be meeting with the school to address some of the issues from the last two weeks. Board Member Marinaro also met with Tax Assessor Martin regarding the statutes and laws from New York State and the impact on the local economy. These discussions will continue. He asked everyone in the community to be safe and to be polite and respectful to each other.

Board Member Franco reiterated that Community Day is Sunday, October 8. The family Halloween costume party will be at Mill Creek Caterers on October 29 from 3 to 5. There will be music, prizes, and lots of fun. You must register to attend. There will be an adult Halloween costume party with a concert and buffet at Mill Creek Caterers on Friday, October 27 from 6:30 to 9:30 PM. It will be \$30 a person with a cash bar. Music will be by Johnny Dell and Night Life and costumes are optional. There will be prizes for costumes. Youth winter basketball program registration ends tomorrow. Adult winter basketball and volleyball start in October. October 1 is a casino trip. October 22 is the Back to the Future Broadway play. November 18 is the Radio City Christmas Spectacular. In late August Board Member Franco had the pleasure of announcing a baseball game for the East Fishkill U12 team. He forgot to thank Mike Miner and Jesse who have both been great to work with. The Veterans Committee met last week. The survey of the property has been completed and this winter they will start clearing some trees for the new Veterans Memorial Park.

Board Member Flores stated she is looking forward to reviewing and discussing the budget. She thanked the Board for their resolutions on the Comprehensive Master Plan. She looks forward to working with the committee. They have a very aggressive schedule and objective to get this done within 12 to 18 months. The first committee meeting will be October 5. They will be initiating a survey shortly to seek the community's input. She encourages everyone to go to the Town's website on the master plan regularly to get updates. She appreciated the invite to Carmel School District regarding the new superintendent search. They discussed the need for a committed leader, good communication, passion and commitment, problem-solving abilities and fiscally responsible. She stated she had the opportunity to visit the Brinkerhoff House for Colonial Days. It was a rainy weekend but it is a wonderful place to go and learn about the history of the Town. She encouraged everyone to visit there and the Depot. Both groups are always looking for volunteers and donations. She looks forward to seeing everyone at Community Day.
