# ZONING VERIFICATION REQUEST

#### HELPFUL HINTS

- Make sure the property is located within the Town of East Fishkill prior to requesting a statement.
- Provide the address of the property and/or the parcel number. This information helps staff to identify the property and expedite your request.
- Requests are processed in the order that they are received. Depending upon department workload, the amount of research involved in completing your request and service demands, ZVS may take up to twenty-one (21) business days to complete provided that all required information and fees are submitted with the application.
- A separate request must be made for each address/parcel.
- All fees are nonrefundable. A ZVS is based upon available records and not all records are available for all properties. If the site is zoned one way but being used another way, the fee will be based on the sites highest potential use (i.e. commercial rather than residential).

## OVERVIEW

# What is a zoning verification statement?

A zoning verification statement ("ZVS") is written confirmation provided by the Town to confirm the current zoning designation of a particular piece of property and the types of uses that are allowed in that zoning district. ZVS are for zoning related items. Staff may not be able to respond to requests that include questions related to topics other than zoning.

# What type of information is provided in a zoning verification statement?

Zoning verification statements contain the following information:

- The assigned address of the subject site
- The legal description of the property
- The current zoning designation of the property and permitted uses
- The overlay district or sector plan affecting the property, if applicable

Zoning verification statements DO NOT include the following:

- Confirmation of the existing development's compliance with current zoning code requirements\*, conformance/nonconformance of existing uses or structures, or reference to building or fire codes
- Copies of site plans, special exceptions, certificates or other approvals
- The zoning designations of abutting or nearby properties
- Reference to any existing property, building or zoning code violations

\*Written confirmation of a property's compliance with current zoning standards, reference to nonconformance/rebuild allowances, parking, and/or types of permitted development on a property are provided through our SITE PLAN REVIEW/APPROVAL process.

The Town typically does not conduct an inspection in conjunction with the ZVS and cannot confirm whether the property is currently in compliance with Town codes. Nonconforming properties are subject to enforcement action.
