REGULAR BOARD MEETING

The Town of East Fishkill's Town Board Meeting on March 28, 2024, was called to order at 6:00 p.m. by Supervisor D'Alessandro with the Pledge of Allegiance to the Flag.

Supervisor's Announcements

Supervisor D'Alessandro stated he had a meeting with the Dutchess County Transportation Safety Council. This is the Metropolitan Planning Organization for Dutchess County. They ensure that all the Federal Transit Funds are spent within Dutchess County. They work on all kinds of transportation studies.

There was the monthly meeting with the Dutchess County Supervisors and Mayors Association in the Town of Washington. This month they voted on the membership and the executive committee. Supervisor D'Alessandro is the Chairman for the Dutchess County Small Government for the Dutchess County Economic Development Advisory Council.

Supervisor D'Alessandro met with the new director of the East Fishkill Library, Kristen Salierno. She has lots of new ideas, which should be good.

There have been several meetings with the Grant Director and the Economic Development Director, Congressman Lawlor, and Senator Schumer. Both have made notice to the Town that they will be providing appropriations to East Fishkill. Senator Schumer is providing \$2 million towards the iPark Water District. New York is committed to incoming semiconductor businesses. Congressman Lawlor is providing \$2 million towards the Pinewood Water District. This is the water interconnection project. The Congressman has also stated they are hoping to secure \$20 million for a company called Emargin. They have a lot of government contracts. Approximately \$18 million will be going towards the facility in East Fishkill for expansion. Supervisor D'Alessandro will keep everyone updated as this progresses. He thanked both men for their assistance and funding.

The annual gala for the Dutchess County Chamber of Commerce was last week. It was a wonderful event at the Grandview in Poughkeepsie. The Chamber of Commerce provides so much help to local business owners.

Supervisor D'Alessandro spoke about negative comments on social media and stated to please contact any of the Board members with any questions on things that are going on in the Town. Their numbers are posted on the website. The things they do are done to help the Town overall.

A first public outreach meeting for the Master Plan was at the Community Center last Thursday night. Over 100 people came out. It was presented very well to the

public. He thanked the committee and Councilman Flores and Town Professionals for all their hard work on this. They will be holding an additional meeting for local businesses as well.

The Economic Development Director and Supervisor went to the FDR library a few weeks ago to accept a grant of \$25,000 for the Master Plan. He thanked the Greenway for the funds and will be applying for another grant through them as well for \$125,000.

The Police Chief and Supervisor attended a ribbon cutting for CAPE of Dutchess County. They opened up a new space by the Department of Motor Vehicles in Wappinger Falls. He stated that Dutchess County is number 2 in the State of New York for overdose deaths.

Last Sunday was a pancake breakfast at the Stormville Fire Department that was attended by the Town Board. Please support them in their fundraising events. He thanked all the volunteers.

He attended a Dutchess County CDAC meeting. They oversee grants given out by Dutchess County. They did make their recommendations to the County Executive who will soon be awarding those grants.

Supervisor D'Alessandro met with the Chairman of the Conservation Advisory Council, Brent Feldweg. They have been working with the Fishkill Creek Water Shed communities. They are trying to designate the Fishkill Creek as a waterway which will help them apply for grants for cleanup or creek protection. Chairman Feldweg will be at the April meeting to present a review to the Town Board. They have started taking down trees and have started the beginning process for

the new Veterans Memorial Park. The Supervisor presented a slide that showed the proposed plan. There will be more information coming as it becomes available.

Motion to adjourn the Public Hearing to consider a Local Law clarifying the definitions for vaping products and distance requirements in the Zoning Ordinance

until the June voting meeting: Board Member Franco. Seconded: Board Member Flores. All voted in favor. Motion carried.

Supervisor D'Alessandro stated they needed more information on this. There are a few other towns reviewing this at the same time and he would like to see what they are considering as well.

2. Open Public Hearing to Consider the Formation of Swartout Water District

Motion to open the Public Hearing to consider the formation of Swartout Water District: Board Member Flores. Seconded: Board Member Marinaro. All vote in favor. Motion carried.

Supervisor D'Alessandro stated this water district is being formed for one property. It is on Joe's Mother's Road. This will be for East Fishkill's first and only senior housing project. They will be getting water from Dutchess County.

Attorney Wood stated the total cost for the district will be paid for by the developer. There is no taxpayer money being spent on this. The Town will take control of the tap to the County water line and infrastructure that the developer has agreed to put on site. This will, in the future, allow for the extension of water along the Route 82 corridor. All costs of building it will be borne by that parcel.

Supervisor D'Alessandro stated to come up with the name Swartout they looked at the historical map of the town and in the past that was referred to as the Swartout area of Town. They did not want to refer to it as Joe's Mother's Road Water District.

Supervisor D'Alessandro asked if there were any comments or questions from Board members. There were none.

Supervisor D'Alessandro asked if there was anyone in the public to speak for or against this update. There were none.

b. Adopt Negative Declaration and Order Establishing Water District

NEGATIVE DECLARATION NOTICE OF DETERMINATION OF NON-SIGNIFICANCE

This notice is issued pursuant to Part 617 of the implementing regulation pertaining to Article 8 (State Environmental Quality Review Act) of the Environmental Conservation Law.

The Town of East Fishkill Town Board has determined that the proposed action described below will not have a significant effect on the environment and a Draft Environmental Impact Statement will not be prepared.

Name of Action: Swartout Water District Creation

Description of Action: The Proposed Action is the creation of the Swartout Water District to service the Hopewell Senior Living Development. The Hopewell Senior Living Development is located on Route 82 near the intersection with Palen Road. The Proposed Action is administrative and would not result in any disturbance. The construction of the new water line proposed to service the Hopewell Senior Living Development was evaluated and approved as part of the SEQR approvals for the project and received a Negative Declaration on 3/21/21. The proposed Swartout Water District will utilize existing source capacity from the Dutchess County Water and Wastewater Authority (DCWWA), which has been approved by the New York State Health Department. The existing DCWWA water system piping ends at the intersection of Fishkill Road and NYS Route 82 and will be extended as part of the Hopewell Senior Living Development. Based on existing design information, the total pipe length needed to extend the water distribution system to serve Hopewell Senior Living was estimated to be approximately 800 feet, consisting of 1 O" water main to be located within the shoulder of NYS Route 82, and a road crossing under same. There are also 3 hydrants, a master water meter and backflow prevention device required for this portion of the extension, which the developer of Hopewell Senior Living will install at his own expense.

3. Reopen Adjourned Public Hearing to Consider Battery Storage Local Law

Motion to reopen the Public Hearing to Consider the Battery Storage Local Law: Board Member Franco. Seconded: Board Member Arco. All vote in favor. Motion carried.

Supervisor D'Alessandro stated they were discussing this several months ago. Last Fourth of July there was a terrible fire in Town. In the garage of this home was over 50,000 lithium ion batteries. There is no law to prohibit someone from doing what that resident was doing. The Town was fortunate that this fire started elsewhere in the house and did not get the batteries. Due to the toxicity of the batteries, the DEC was involved. There was fear of contamination to the water tables. Attorney Wood stated that if adopted this local law would restrict the creation of commercial battery facilities to the industrial parcels in the Town. It limits batteries on any other properties within the Town to batteries which are utilized on the product which they are intended for. If someone has an electric car and the battery is in the car that is allowed. They can have reasonable excess batteries. Anyone who proposes a battery storage facility must apply to the Town Board to be granted a Special Permit. It would then go to the Planning Board and they would do a site specific review and plan. It brings into play many of the State and national codes, building codes or any other regulatory codes that need to be complied with. It also requires certification from the local utility company that the facility is needed in the system and can be connected into the system. He does believe that as time progresses, this law will be amended to add or create more provisions that continue to keep the Town up to date. The current zoning allows any public utility in any district of the Town. This proposal would clearly limit this use into the industrial zones. This is probably not a perfect law as none of them are but it will be a good start to get it on the books.

Supervisor D'Alessandro asked if there were any comments or questions from Board members.

Board Member Flores asked if this was for industrial facilities as opposed to residents. Attorney Wood stated this does not include batteries for a consumer product. His understanding of the home owner involved in the July 4th incident is that they had way more batteries than devices. This will not lend itself to an inspection of every house to see if they are in compliance, but if they do find proof that someone is charging batteries beyond the demands of normal consumer usage, they would have leverage under this law to issue a violation. As to commercial facilities, they would be limited to the current industrial zones. Board Member Flores stated that as it is written, she does not believe it differentiates between the size and capacity or the number of batteries. She asked if they should. Engineer Bryant stated under the battery use storage system it states it is one or more devices connected together.

Board Member Arco stated in the industrial zoning it still requires Planning Board approval. Attorney Wood stated there are two levels. The Town Board has to agree that the site is appropriate, and then Planning Board does the site specific spacing requirements, screening, and security. There is a provision for a Decommissioning Bond to be posted. It is a similar process to the solar panels.

Supervisor D'Alessandro asked about enforcement. Attorney Wood stated there are fines in place for violations. The fine can be up to \$3000 a week for each week that the violation occurs. They can also seek conjunctive relief from the Supreme Court for a Cease and Desist order. If that order is failed, the Justice of the Supreme Court can imprison them until they comply. Supervisor D'Alessandro asked if the process was the same as zoning enforcement and Attorney Wood said yes. There is due process. There is notice and time to correct. If it is a life

safety issue, a notice can be issued with an immediate correction required.

Supervisor D'Alessandro asked if there was anyone in the public to speak for or against this new law for battery storage systems. There was no one.

a. Close Public Hearing

<u>Local Law No. 2 of 2024</u> (A LOCAL LAW ADDING PROVISIONS TO THE TOWN CODE WITH RESPECT TO BATTERY ENERGY STORAGE SYSTEMS)

Section 1. Legislative Intent

Throughout the region, there has been an increase in the number of battery energy storage operators submitting proposals to municipalities. Due to safety concerns, most areas of the Town are inappropriate for battery energy storage systems. The Town Board seeks to codify requirements to ensure the safety and health of the residents of East Fishkill.

Section 2. Additions to the Town Code

The following provisions shall be added to the Town Code in relation to Battery Energy Storage Systems:

1. Statement of Purpose

This Battery Energy Storage System Law is adopted to advance and protect the public health, safety, welfare, and quality of life of the of East Fishkill by creating regulations for the installation and use of battery energy storage systems, with the following objectives:

A. To provide a regulatory scheme for the designation of properties suitable for the location, construction, and operation of battery energy storage systems;

B. To ensure compatible land uses in the vicinity of the areas affected by battery energy storage systems; and

C. To mitigate the impacts of battery energy storage systems on environmental resources such as important agricultural lands, forests, wildlife, and other protected resources

2. Definitions

As used in this Chapter, the following terms shall have the meanings indicated:

ANSI: American National Standards Institute

BATTERY(IES): A single cell or a group of cells connected together electrically in series, in parallel, or a combination of both, which can charge, discharge, and store energy electrochemically. For the purposes of this law, batteries utilized in consumer products are excluded from these requirements.

BATTERY ENERGY STORAGE MANAGEMENT SYSTEM: An electronic system that protects energy storage systems from operating outside their safe operating parameters and disconnects electrical power to the energy storage system or places it in a safe condition if potentially hazardous temperatures or other conditions are detected.

BATTERY ENERGY STORAGE SYSTEM: One or more devices, assembled together, capable of storing energy in order to supply electrical energy at a future time, not to include a stand-alone 12-volt car battery or an electric motor vehicle.

CELL: The basic electrochemical unit, characterized by an anode and a cathode, used to receive, store, and deliver electrical energy.

COMMISSIONING: A systematic process that provides documented confirmation that a battery energy storage system functions according to the intended design criteria and complies with applicable code requirements.

DEDICATED-USE BUILDING: A building that is built for the primary intention of housing battery energy storage system equipment, is classified as Group H occupancy as defined in the International Building Code, and complies with the following:

1) The building's only use is battery energy storage, energy generation, and other electrical grid-related operations.

2) No other occupancy types are permitted in the building.

3) Occupants in the rooms and areas containing battery energy storage systems are limited to personnel that operate, maintain, service, test, and repair the battery energy storage system and other energy systems.

4) Administrative and support personnel are permitted in areas within the buildings that do not contain battery energy storage system, provided the following:

a. The areas do not occupy more than 10 percent of the building area of the story in which they are located.

b. A means of egress is provided from the administrative and support use areas to the public way that does not require occupants to traverse through areas containing battery energy storage systems or other energy system equipment.

ENERGY CODE: The New York State Energy Conservation Construction Code adopted pursuant to Article 11 of the Energy Law, as currently in effect and as hereafter amended from time to time.

FIRE CODE: The fire code section of the New York State Uniform Fire Prevention and Building Code adopted pursuant to Article 18 of the Executive Law, as currently in effect and as hereafter amended from time to time.

NATIONALLY RECOGNIZED TESTING LABORATORY (NRTL): A U.S. Department of Labor designation recognizing a private sector organization to perform certification for certain products to ensure that they meet the requirements of both the construction and general industry OSHA electrical standards.

NEC: National Electric Code.

NFPA: National Fire Protection Association.

NON-DEDICATED-USE BUILDING: All buildings that contain a battery energy storage system and do not comply with the dedicated-use building requirements.

NON-PARTICIPATING PROPERTY: Any property that is not a participating property.

NON-PARTICIPATING RESIDENCE: Any residence located on non-participating property.

OCCUPIED COMMUNITY BUILDING: Any building in Occupancy Group A, B, E, I, R, as defined in the International Building Code, including but not limited to schools, colleges, daycare facilities, hospitals, correctional facilities, public libraries, theaters, stadiums, apartments, hotels, and houses of worship.

PARTICIPATING PROPERTY: A battery energy storage system host property or any real property that is the subject of an agreement that provides for the payment of monetary

compensation to the landowner from the battery energy storage system owner (or affiliate) regardless of whether any part of a battery energy storage system is constructed on the property.

UNIFORM CODE: the New York State Uniform Fire Prevention and Building Code adopted pursuant to Article 18 of the Executive Law, as currently in effect and as hereafter amended from time to time.

3. Applicability

A. The requirements of this Local Law shall apply to all battery energy storage systems permitted, installed, or modified in the Town of East Fishkill after the effective date of this Local Law, excluding general maintenance and repair.

B. Battery energy storage systems constructed or installed prior to the effective date of this Local Law shall not be required to meet the requirements of this Local Law.

C. Modifications to, retrofits, or replacements of an existing battery energy storage system that increase the total battery energy storage system designed discharge duration or power rating shall be subject to this Local Law.

4. General Requirements

A. A building permit and an electrical permit shall be required for installation of all battery energy storage systems.

B. Issuance of permits and approvals by the Planning Board shall include review pursuant to the State Environmental Quality Review Act.

C. All battery energy storage systems, all Dedicated Use Buildings, and all other buildings or structures that (1) contain or are otherwise associated with a battery energy storage system and (2) subject to the Uniform Code and/or the Energy Code shall be designed, erected, and installed in accordance with all applicable provisions of the Uniform Code, all applicable provisions of the Energy Code, and all applicable provisions of the codes, regulations, and industry standards as referenced in the Uniform Code, the Energy Code, and the Town Code.

5. Permitting Requirements for Battery Energy Storage Systems

Battery Energy Storage Systems are permitted through the issuance of a Special Permit by the Town Board and Site Plan Review issued by the Planning Board within the I-1 District, I-2 District, I-3 District, and shall be subject to the Uniform Code and the site plan application requirements set forth in this Section.

6. Permitting Requirements for Battery Energy Storage Systems

Battery Energy Storage Systems are permitted through the issuance of a special permit from the Town Board and within the I-1 District, I-2 District, I-3 District, and zoning districts, and shall be subject to the Uniform Code and the site plan application requirements set forth in this Section.

A. Applications for the installation Battery Energy Storage System shall be:

1) reviewed by the Engineering, Planning, and Building Departments for completeness. An application shall be complete when it addresses all matters listed in this Local Law including, but not necessarily limited to: (i) compliance with all applicable provisions of the Uniform Code and all applicable provisions of the Energy Code and (ii) matters relating to the proposed battery energy storage system and Floodplain, Utility Lines and Electrical Circuitry, Signage, Lighting, Vegetation and Tree-cutting, Noise, Decommissioning, Site Plan and Development, Special Use and Development, Ownership Changes, Safety, and Permit Time Frame and Abandonment.

2) subject to a public hearing to hear all comments for and against the application as required by Chapter 194 of the Town Code. The Town Board is not required to have a Public Hearing if it believes that the Planning Board Public Hearing was sufficient.

3) referred to the Dutchess County Planning Department pursuant to General Municipal Law § 239-m if required.

B. Utility Lines and Electrical Circuitry. All on-site utility lines shall be placed underground to the extent feasible and as permitted by the serving utility, with the exception of the main service connection at the utility company right-of-way and any new interconnection equipment, including without limitation any poles, with new easements and right-of-way.

C. Signage.

1) The signage shall be in compliance with ANSI Z535 and shall include the type of technology associated with the battery energy storage systems, any special hazards associated, the type of suppression system installed in the area of battery energy storage systems, and 24-hour emergency contact information, including reach-back phone number.

2) As required by the NEC, disconnect and other emergency shutoff information shall be clearly displayed on a light reflective surface. A clearly visible warning sign concerning voltage shall be placed at the base of all pad-mounted transformers and substations.

D. Lighting. Lighting of the battery energy storage systems shall be limited to that minimally required for safety and operational purposes and shall be reasonably shielded and downcast from abutting properties.

E. Vegetation and tree-cutting. The site shall be cleared of combustible vegetation and other combustible growth. Single specimens of trees, shrubbery, or cultivated ground cover such as green grass, ivy, succulents, or similar plants used as ground covers shall be permitted to be exempt provided that they do not form a means of readily transmitting fire. Removal of trees should be minimized to the extent possible.

F. Noise. The 1-hour average noise generated from the battery energy storage systems, components, and associated ancillary equipment shall not exceed a noise level as described in the noise ordinance of the Town Code as measured at the outside wall of any non-participating residence or occupied community building. Applicants may submit equipment and component manufacturers noise ratings to demonstrate compliance. The applicant may be required to provide Operating Sound Pressure Level measurements from

a reasonable number of sampled locations at the perimeter of the battery energy storage system to demonstrate compliance with this standard.

G. Decommissioning.

1) Decommissioning Plan. The applicant shall submit a decommissioning plan, developed in accordance with the Uniform Code, to be implemented upon abandonment and/or in conjunction with removal from the facility. The decommissioning plan shall include:

a. A narrative description of the activities to be accomplished, including who will perform that activity and at what point in time, for complete physical removal of all battery energy storage system components, structures, equipment, security barriers, and transmission lines from the site;

b. Disposal of all solid and hazardous waste in accordance with local, state, and federal waste disposal regulations;

c. The anticipated life of the battery energy storage system;

d. The estimated decommissioning costs and how said estimate was determined;

e. The method of ensuring that funds will be available for decommissioning and restoration;

f. The method by which the decommissioning cost will be kept current;

g. The manner in which the site will be restored, including a description of how any changes to the surrounding areas and other systems adjacent to the battery energy storage system, such as, but not limited to, structural elements, building penetrations, means of egress, and required fire detection suppression systems, will be protected during decommissioning and confirmed as being acceptable after the system is removed; and

h. A listing of any contingencies for removing an intact operational energy storage system from service, and for removing an energy storage system from service that has been damaged by a fire or other event.

2) Security.

a. The deposit, execution, or filing with the Town Clerk of a cash, bond, or other form of security reasonably acceptable to the Town Attorney and/or the Town Engineer, shall be in an amount sufficient to ensure the good faith performance of the terms and conditions of the permit issued pursuant hereto and to provide for the removal and restorations of the site subsequent to removal. The amount of the bond or security shall be 200% of the cost of removal of the Battery Energy Storage System and restoration of the property with an escalator of 2% annually for the life of the Battery Energy Storage System.

b. In the event of default upon performance of such conditions, after proper notice and expiration of any cure periods, the cash deposit, bond, or security shall be forfeited to the Town, which shall be entitled to maintain an action thereon. The cash deposit, bond, or security shall remain in full force and effect until restoration of the property as set forth in the decommissioning plan is completed.

c. In the event of default or abandonment of the solar energy system, the system shall be decommissioned as set forth herein.

H. Site plan application. For a Battery Energy Storage System, site plan approval shall be required. Any site plan application shall include the following information plus all other Site Plan requirements found throughout the Town Code:

1) Property lines and physical features, including roads, for the project site.

2) Proposed changes to the landscape of the site, grading, vegetation clearing and planting, exterior lighting, and screening vegetation or structures.

3) An electrical diagram detailing the battery energy storage system layout, associated components, and electrical interconnection methods, with all National Electrical Code compliant disconnects and over current devices.

4) A preliminary equipment specification sheet that documents the proposed battery energy storage system components, inverters, and associated electrical equipment that are to be installed. A final equipment specification sheet shall be submitted prior to the issuance of building permit.

5) Name, address, and contact information of proposed or potential system installer and the owner and/or operator of the battery energy storage system. Such information of the final system installer shall be submitted prior to the issuance of building permit.

6) Name, address, phone number, and signature of the project Applicant, as well as all the property owners, demonstrating their consent to the application and the use of the property for the battery energy storage system.

7) Zoning district designation for the parcel(s) of land comprising the project site.

8) Commissioning Plan. Such plan shall document and verify that the system and its associated controls and safety systems are in proper working condition per requirements set forth in the Uniform Code. Where commissioning is required by the Uniform Code, Battery energy storage system commissioning shall be conducted by a New York State (NYS) Licensed Professional Engineer after the installation is complete but prior to final inspection and approval. A corrective action plan shall be developed for any open or continuing issues that are allowed to be continued after commissioning. A report describing the results of the system commissioning and including the results of the initial acceptance testing required in the Uniform Code shall be provided to the Town Engineer prior to final inspection and approval and maintained at an approved on-site location.

9) Fire Safety Compliance Plan. Such plan shall document and verify that the system and its associated controls and safety systems are in compliance with the Uniform Code. The Applicant must satisfy all comments from the Fire Advisory Board. The Applicant shall be solely responsible for purchasing any new equipment required to ensure the safety of the community.

10) Operation and Maintenance Manual. Such plan shall describe continuing battery energy storage system maintenance and property upkeep, as well as design, construction, installation, testing, and commissioning information and shall meet all requirements set forth in the Uniform Code.

11) Erosion and sediment control and storm water management plans prepared to New York State Department of Environmental Conservation standards, if applicable, and to such standards as may be established by the Planning Board.

12) Prior to the issuance of the building permit or final approval by the Planning Board, but not required as part of the application, engineering documents must be signed and sealed by a NYS Licensed Professional Engineer.

13) Emergency Operations Plan. A copy of the approved Emergency Operations Plan shall be given to the system owner, the local fire department, and local fire code official. A permanent copy shall also be placed in an approved location to be accessible to facility personnel, fire code officials, and emergency responders. The emergency operations plan shall include the following information:

a. Procedures for safe shutdown, de-energizing, or isolation of equipment and systems under emergency conditions to reduce the risk of fire, electric shock, and personal injuries, and for safe start-up following cessation of emergency conditions.

b. Procedures for inspection and testing of associated alarms, interlocks, and controls.

c. Procedures to be followed in response to notifications from the Battery Energy Storage Management System, when provided, that could signify potentially dangerous conditions, including shutting down equipment, summoning service and repair personnel, and providing agreed upon notification to fire department personnel for potentially hazardous conditions in the event of a system failure.

d. Emergency procedures to be followed in case of fire, explosion, release of liquids or vapors, damage to critical moving parts, or other potentially dangerous conditions. Procedures can include sounding the alarm, notifying the fire department, evacuating personnel, de-energizing equipment, and controlling and extinguishing the fire.

e. Response considerations similar to a safety data sheet (SDS) that will address response safety concerns and extinguishment when an SDS is not required.

f. Procedures for dealing with battery energy storage system equipment damaged in a fire or other emergency event, including maintaining contact information for personnel qualified to safely remove damaged battery energy storage system equipment from the facility.

g. Other procedures as determined necessary by the Town to provide for the safety of occupants, neighboring properties, and emergency responders.

h. Procedures and schedules for conducting drills of these procedures and for training local first responders on the contents of the plan and appropriate response procedures.

I. Special Use Permit Standards.

1) Setbacks. The principal structure of the Battery Energy Storage Systems shall be located at least 1,500 feet away from the nearest structure and 5,000 feet away from the nearest residential structure.

2) Height. Battery Energy Storage Systems shall comply with the building height limitations for principal structures of the underlying zoning district.

3) Fencing Requirements. Battery Energy Storage Systems, including all mechanical equipment, shall be enclosed by an 8-foot-high fence with a self-locking gate to prevent unauthorized access unless housed in a dedicated-use building and not interfering with ventilation or exhaust ports.

4) Screening and Visibility. Battery Energy Storage Systems shall have views minimized from adjacent properties to the extent reasonably practicable using architectural features, earth berms, landscaping, or other screening methods that will harmonize with the character of the property and surrounding area and not interfering with ventilation or exhaust ports.

J. Ownership Changes. If the owner of the battery energy storage system changes or the owner of the property changes, the special use permit shall remain in effect, provided that the successor owner or operator assumes in writing all of the obligations of the special use permit, site plan approval, and decommissioning plan. A new owner or operator of the battery energy storage system shall notify the Building Department of such change in ownership or operator within thirty (30) days of the ownership change. A new owner or operator must provide such notification to the Building Department in writing. The special use permit and all other local approvals for the battery energy storage system would be void if a new owner or operator fails to provide written notification to the Building Department in the required timeframe. Reinstatement of a void special use permit will be subject to the same review and approval processes for new applications under this Local Law.

7. Safety

A. System Certification. Battery energy storage systems and equipment shall be listed by a Nationally Recognized Testing Laboratory to UL 9540 (Standard for battery energy storage systems and Equipment) or approved equivalent, with subcomponents meeting each of the following standards as applicable:

1) UL 1973 (Standard for Batteries for Use in Stationary, Vehicle Auxiliary Power and Light Electric Rail Applications),

2) UL 1642 (Standard for Lithium Batteries),

3) UL 1741 or UL 62109 (Inverters and Power Converters),

4) Certified under the applicable electrical, building, and fire prevention codes as required.

5) Alternatively, field evaluation by an approved testing laboratory for compliance with UL 9540 (or approved equivalent) and applicable codes, regulations and safety standards may be used to meet system certification requirements.

B. Site Access. Battery energy storage systems shall be maintained in good working order and in accordance with industry standards. Site access shall be maintained, including snow removal at a level acceptable to the local fire department and the local ambulance corps.

C. Battery energy storage systems, components, and associated ancillary equipment shall have required working space clearances, and electrical circuitry shall be within weatherproof enclosures marked with the environmental rating suitable for the type of exposure in compliance with NFPA 70.

8. Permit Time Frame and Abandonment

A. The Special Use Permit and site plan approval for a battery energy storage system shall be valid for a period of 24 months, provided that a building permit is issued for construction during this time. In the event construction is not completed in accordance with the final site plan, as may have been amended and approved, as required by the Planning Board, within 24 months after approval, the Town may extend the time to complete construction. If the owner and/or operator fails to perform substantial construction after 36 months, the approvals shall expire.

B. The battery energy storage system shall be considered abandoned when it ceases to operate consistently for more than twelve (12) months. If the owner and/or operator fails to comply with decommissioning upon any abandonment, the Town may, at its discretion, enter the property and utilize the available bond and/or security for the removal of a Battery Energy Storage System and restoration of the site in accordance with the decommissioning plan.

9. Enforcement

Any violation of this Battery Energy Storage System Law shall be subject to the same enforcement requirements, including the civil and criminal penalties, provided for in the zoning or land use regulations of the Town Code.

10. Public Benefit Contribution

Each applicant for a Battery Energy Storage System shall be required to enter into a public benefit contribution agreement to benefit police, fire, basic life support, and advanced life support services in the Town of East Fishkill. Sufficiency of the contribution and duration of the agreement shall be determined by the Town Board.

Section 3. Severability

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 4. Effective date

This local law shall take effect immediately upon filing with the Secretary of State.

WHEREAS, the maximum estimated cost to said Water Districts of such joint increase and improvement of facilities is determined to be \$16,700,000; and

WHEREAS, such cost shall be annually apportioned among such Water Districts by said Town Board, and the amounts so apportioned shall be annually apportioned and assessed upon the several lots and parcels of land within each said Water District benefitted thereby, and as otherwise provided by law, in an amount sufficient to pay the principal and interest on said bonds as the same become due, but if not paid from such source, all the taxable real property in said Town shall be subject to the levy of ad valorem taxes without limitation as to rate or amount sufficient to pay the principal of and interest on said bonds as the same shall become due; and

WHEREAS, it is anticipated at this time that the apportionment of such cost between the following Water Districts shall be Beckman Water District (\$1,480,553.35), Four Corners Water District (\$8,442,199.80), Hopewell Hamlet Water District (\$3,178,298.30), Hopewell North Water District (\$545,232.05), Little Switzerland Water District (\$272,616.03), and Pinewood Knolls Water District (\$2,809,296); and

WHEREAS, the components of such joint increase and improvements shall be as follows:

Beckman Water District:	Construction of new well and improvements to water treatment plant, and interconnection improvements
Four Corners Water District:	Interconnection improvements
Hopewell Hamlet Water District:	Wells mitigation and ion exchange improvements
Hopewell North Water District:	Interconnection improvements
Little Switzerland Water District:	Interconnection improvements
Pinewood Knolls Water District:	Interconnection improvements

Including in each case original furnishings, equipment, machinery, apparatus, appurtenances and incidental improvements and expenses, as well as water main and water meter buildings as interconnection improvements, as applicable; and

Budget Transfer:

Supervisor D'Alessandro stated there are no budget transfers at this time.

Comments from Town Board Members:

Highway Superintendent Williams stated they completed all of the drainage work on Wilmont Court. They will be doing some patchwork next week. They are continuing to patch potholes throughout Town. They are doing catch basin repairs in the Eisenhower development. The Grade-all has been out where they have had some washouts due to the heavy rain. They have been fixing broken curbing and some plow damage. The tree crews have been out clearing dead trees throughout Town. They have also been working over in Veterans' Park. They finished building the log truck in the garage. They converted it over from the old Jet-Vac truck. The new Jet-Vac has been out cleaning out catch basins throughout the Town. The street sweepers will be starting next month.

Chief Cuccia stated the crime report is low, which is a good thing. He thanked the Supervisor for attending the CAPE meeting. The County is, unfortunately, the second in the state for overdose deaths. East Fishkill is a smaller percent of the problem. On St. Patrick's Day there was a successful DWI checkpoint. It was multi agency so he thanked the Sheriff's Department and the New York State Police for participating with East Fishkill officers. They are starting to kick off their grant fund for aggressive driving details along with seatbelts. They will be enforcing things in Hillside Lake for this upcoming month. Town Cleanup is on April 6. There is usually a large contingency from the Police Department. The PBA supports this as well. The PBA also sponsors the Easter egg hunt with the petting zoo and obstacle course. They have one recruit at the Westchester Academy and one recruit at the Rockland Police Academy and they are both doing very well. They

will graduate in May and June. There was taser training last month and this month they will be working with stop sticks.

Board Member Arco stated he and Highway Superintendent Williams have been evaluating cost savings, labor, and parts acquisition. He thanked Joe Angot and Tom Knapp for the work on the old Jet-vac truck. They took it off the frame and built a log truck from scratch. They did an awesome job. They have been evaluating multiple software solutions in regard for proactive routine Town Highway work, and scheduling maintenance work on buildings and vehicles. He met with the Comptroller and reviewed the annual software costs, and he will be reviewing those numbers with the Supervisor. He is being taught the operations of the Police Department as well as what the Chief's responsibilities are. The Police Chief and Board Member Arco have been reviewing tasks that Board Member Arco can help with. He will also be doing ride-a-longs over the next two months. He would also like to sit with the dispatchers. The cameras have been distributed this week.

Board Member Marinaro stated he and the Supervisor met with the group regarding the status of Dutchess County EMS. They did discuss the national crisis and lack of first responders. One of their suggestions was to share costs among all of the municipalities in Dutchess County and giving seminars on proper use of EMS services for the future. Board Member Marinaro stated this is a national crisis. They did discuss increasing salaries as an option. He gave the monthly report from the fire department regarding their responses for the month. He stated he attended a meeting with the Board of Fire Commissioners on March 11. The volunteer fire district saves taxpayers a large sum of money. Last month was Black History Month and he stated that East Fishkill is an all-inclusive community with respect for all its citizens. He wished the community a happy and peaceful Easter.

Board Member Franco thanked the Highway Department for getting rid of all of the wood at the future Veterans Memorial Park. April 1 is the Town Spring Community Food Drive. The Town Hall is a drop-off location as well as the Recreation Office and the Highway Department. April 6 is Cleanup Day. Registration is at the Town Hall from 8 AM to 8:30 AM. You will be fed coffee and snacks. The East Fishkill Police Department will be there. The annual Easter Equ Hunt is also that day from 12:30 PM to 2:30 PM. April 12 is the Howland Chamber Music Circle Concert, sponsored by the Town, and held at the library at 6:30 PM. Supervisor D'Alessandro stated this was very well done last year. Board Member Franco stated Opening Day is April 13 for soccer and baseball and there will be a parade at 9 AM starting in the fields and ending at Field 3. Special thanks to Christine Selback for bringing that back. Women's basketball registration can be done online or at the recreation office. Games will start on June 3 and will be held on Mondays at Hopewell Recreation. April 1 starts adult registration for pickleball clinic being held in May at the Lime Kiln facility. Summer camp registration is still open.

Board Member Flores stated they are six months into the master plan work. It is a very aggressive schedule, and she appreciates everyone that came out for their workshop. There were very engaged members of the community participating. She thanked Jennifer Bolger from the John Jay Photo Club who acted as their photographer. She is proud and appreciative of all of the work of the volunteer committee. The next committee meeting is April 4, and they will continue the discussion on housing and start the discussion on traffic. They are also working on drafting the chapters of the documents that they have already discussed. This is a very open process. Although the meetings are not televised, they are open to the public and all materials are posted on the website. They welcome any suggestions or questions. They do plan on doing additional outreach. There will be consultants presenting at the Town Board Workshop April 11, and they will be meeting with business owners in April, as well as the senior group. There will be a public session possibly planned for August time frame. She wished everyone a happy Easter.

Supervisor D'Alessandro stated the next workshop is April 11. He wished everyone a happy, healthy, and pleasant Easter.
